a. Meet your new Emergency Management Executive Director & Receive a Covid-19 Vaccine Update

Palm Beach County Emergency Management

Ms. Blakeney provided membership with a Codi-19 vaccination update. A PowerPoint presentation was displayed reflecting the history & timeline of where we’ve been from the start of Covid-19 and where we are now. Vaccines arrived in PBC in December 2020 and the PBC Emergency Operations Center (EOC) has been activated for 345 days in response to the pandemic. The EOC team is still activated and have weekly calls with updates. Ms. Blakeney mentioned that the vaccine distribution including the Governor’s Executive Order 20-315 is still in effect today. Palm Beach County has been collaborating with the Department of Health and the multi-agency TEAM efforts in regards to the pandemic. In conclusion, she reminded membership to avoid large gatherings, continue to wash hands, wear masks, and socially distance.
